What do I do as a Certified Vested Practitioner?

The Practitioner Certification is ideal for individuals who want to move from “understanding” Vested to “applying” Vested in a real-world project

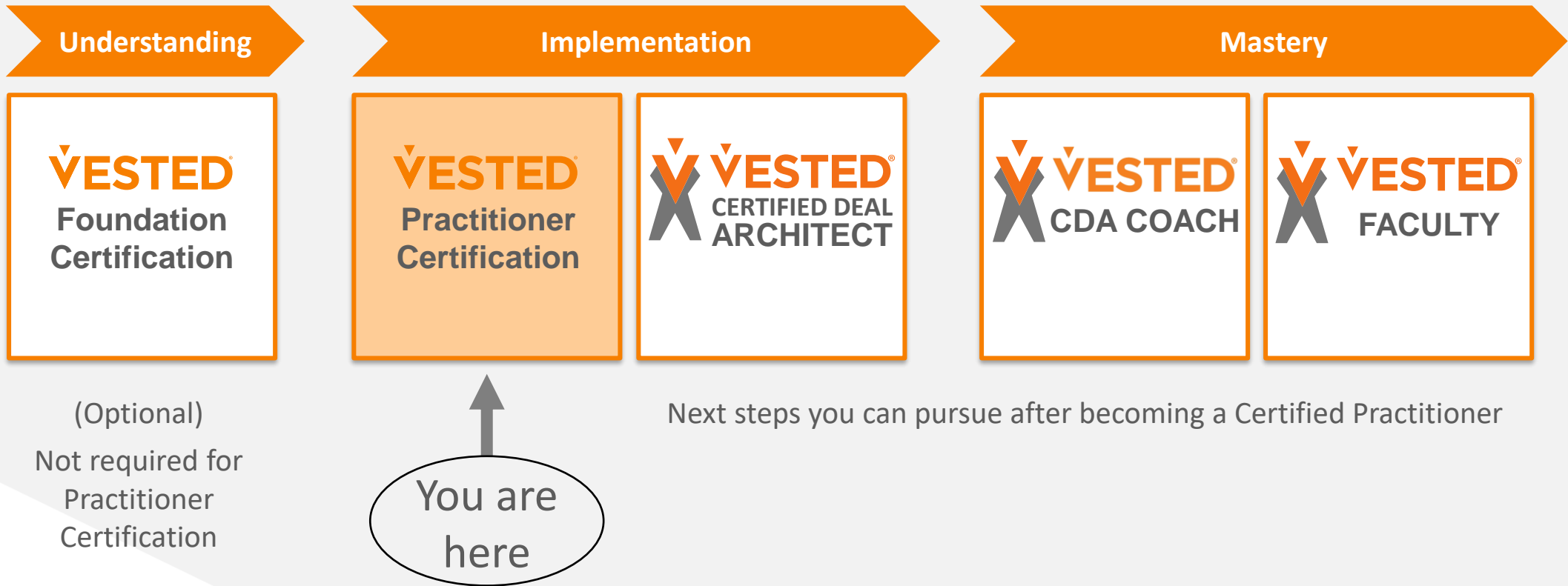
- Practitioners are individuals who apply Vested concepts during the contracting phase for a real-world Vested agreement
- The Practitioner Certification is perfect for individuals who want to gain a working knowledge of Vested without going through the rigor of becoming a Certified Deal Architect





Where is Practitioner in the Vested Certification levels?

The Practitioner Certification is the 2nd of five Vested Certification levels





Practitioner Certification: Courses You Must Have Taken

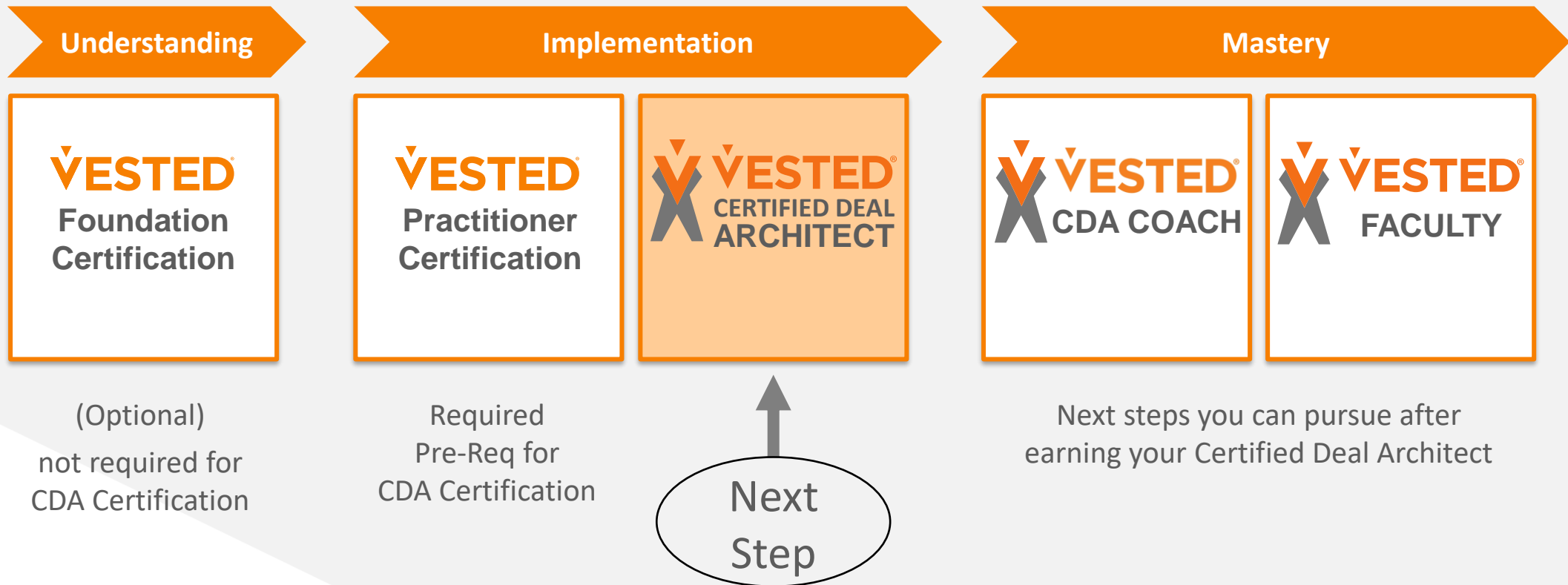




Next Step: Becoming a Certified Deal Architect
